Anecdotally that Native women in Duluth were not getting a very good police response when they reported sexual violence. ■ Wanted to get substantive information that could promote action to change things for the better. Getting Buy-In Not difficult at all. □ We received a state Office of Justice Programs grant. □ Duluth's long history of addressing domestic violence collaboratively helped - got agencies on-board to look at sexual violence similarly.

Scope and Focus: How did you determine?	
 Tough process Started out too ambitious Kept trying to map the whole criminal justice process after a rape is reported. It was too big. We spent quite some time narrowing it down – finally focused on police and advocacy response to Native women who reported to the police that they'd been raped, in Duluth.

Findings □ We didn't think we'd find many reports We didn't think we'd find a very good response. Our first plan was to take at least a couple of cases that were prosecuted and map them all the way through the system. □ We found over fifty police reports from a 2 or 3 year period. □ There were NO charging recommendations sent to the county attorney's office. How did the team react to the Findings? Combination of disbelief, shock, anger, renewed energy to address the problems. ☐ Tired sort of validation, depending on the profession of the person reacting. **Recommendations?** □ Changes to Duluth Police Department's response to any sexual assault, staffing changes, □ Changes to PAVSA □ Particularly in their attempts to diversify their staff and Board.
